# Sailing Club Uskok - Zadar - Croatia

#### 1. RULES

- 1.1. The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2. No national prescriptions will apply.
- 1.3. If there is a conflict between languages the English text will take precedence.

# 2. ELIGIBILITY AND ENTRY

- 2.1. The regatta is open to all boats of the 420 class.
- 2.2. Eligible boats may enter by completing the attached form and sending it to tonko@globalnet.hr by 15. 02. 2018.
- 2.3. Entry fee may be payed on registration in cash or on bank acount please ask for details.

#### 3. FEES

Entry fee will be 25 Euro per boat.

#### 4. SCHEDULE

- 4.1. Registration will be on 15. 02. 2018. from 1800 to 2100.
- 4.2. Dates of racing will be from 16. 02. to 18. 02. 2018.
- 4.3. Three races per day are scheduled.
- 4.4. The scheduled time of the warning signal for the first race each day is 1000.
- 4.5. On the last scheduled day of racing no warning signal will be made after 1400.

### 5. MEASUREMENT

Each boat shall produce a measurement certificate.

# 6. SAILING INSTRUCTIONS

The sailing instructions will be available after 1700 on 15. 02. at Race office.

## 7. VENUE

- 7.1. Attachment A shows the location of the regatta harbour.
- 7.2. Attachment B shows the location of the racing areas.

#### 8. THE COURSES

Trapezoid course will be sailed.

## 9. SCORING

- 9.1. Three races are required to be completed to constitute a series.
- 9.2. When fewer than 4 races have been completed, a boat's series score will be the total of her race scores.

# 10. RADIO COMMUNICATION

Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats. [DP]

### 11. PRIZES

Prizes will be given as follows: First three crews overall, First three women crew overall, First three men crews U17, First three women crew U17.

# 12. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

### 13. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of 1.000.000 euro per incident or the equivalent.
